

SUMMARY ANNUAL REPORT

For Roanoke College Defined Contribution Retirement Plan

This is a summary of the annual report Form 5500 Annual Return/Report of Employee Benefit Plan for Roanoke College Defined Contribution Retirement Plan, EIN 54-0505945, Plan No. 001, for period January 1, 2024 through June 30, 2024. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a single-employer defined contribution plan.

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$5,634,479. These expenses included \$58,659 in administrative expenses, and \$5,575,820 in benefits paid to participants and beneficiaries. A total of 0 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$0 as of June 30, 2024, compared to \$151,649,996 as of January 1, 2024. During the plan year the plan experienced a decrease in its net assets of \$151,649,996. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$11,787,375, including employer contributions of \$497,795, employee contributions of \$771,426, rollover contributions of \$135,897, earnings from investments of \$10,335,046, and plan servicing credits of \$47,211. Plan assets of \$157,802,892 were transferred to the Section 403(b) Defined Contribution Plan for Tax-Exempt Colleges and Universities in Virginia.

The plan has a contract with TIAA-Cref.
