

SUMMARY ANNUAL REPORT

For Virginia Private Colleges Benefits Consortium, Inc. Health Plan

This is a summary of the annual report of the Virginia Private Colleges Benefits Consortium, Inc. Health Plan, EIN 27-1367957, Plan No. 501, for period January 1, 2024 through December 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Anthem Health Plans of Virginia, Inc., Delta Dental of Virginia, Employer Direct Healthcare, LLC and Unicare Life & Health Inc. to pay health, dental, vision, stop loss, PPO and surgery plus claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2024 were \$1,780,310.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending December 31, 2024, the premiums paid under such "experience-rated" contracts were \$14,099 and the total of all benefit claims paid under these contracts during the plan year was \$1,668,055.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$17,509,553 as of December 31, 2024, compared to \$16,841,351 as of January 1, 2024. During the plan year the plan experienced an increase in its net assets of \$668,202. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$44,976,935, including employer contributions of \$30,166,819, employee contributions of \$13,780,214, earnings from investments of \$1,029,402, and other income of \$500.

Plan expenses were \$44,308,733. These expenses included \$4,614,976 in administrative expenses, and \$39,693,757 in benefits paid to participants and beneficiaries.
